

Kishor Gulabivala, BDS, MSc, FDS RCS, PhD, FHEA (ENGLAND)

Dr. Gulabivala is Head of Endodontology and Restorative Dentistry at UCL Eastman Dental Institute in London. He is an honorary Consultant in Restorative Dentistry at the Eastman Dental Hospital, University College London and Hospital Trusts. He currently holds the post of Training Programme Director for Endodontics at Health Education London. He developed and heads Masters and Specialist level postgraduate programs in Endodontology. He is on the UK Specialist Lists in Restorative Dentistry, Prosthodontics and Endodontics (2000). His PhD was on microbial infections of teeth (2004) and his research interests focus on Endodontology and outcomes of endodontic treatment.

Topic: A synthesis of biological and clinical data on the outcomes of root canal treatment



Pierre Machtou, DDS, MS, PhD, FICD (FRANCE)

Dr. Machtou graduated in 1967 from the Paris 7-Denis Diderot University. He completed his training and became full professor at the same University in 1997 and served as Vice-Dean from 1998 to 2008. He is a member of numerous national and international endodontic and dental societies and a Fellow of the International College of Dentists. In 2006, he was the recipient of the Pierre Fauchard's Elmer S. Best Memorial Award. Dr. Machtou lectured extensively and held seminars in many countries worldwide. He is the author of two books and co-editor of one endodontic textbook. He wrote 11 textbook chapters and 70 articles in peer-reviewed journals. He has limited his practice to Endodontics since 1978 and is

currently the co-director of the European Society of Endontology certified graduate endodontic program in Paris.

J. Craig Baumgartner, DDS, MS, PhD (USA)

Dr. Baumgartner received a BS in Pharmacy from the University of Wisconsin, a DDS from the University of Minnesota, an MS in Oral Biology from George Washington University and a PhD in Microbiology/Immunology from the University of Maryland. He is a Diplomate and Past President of the American Board of Endodontics. He is currently Professor Emeritus at the Oregon Health and Science University. He published over 100 articles and was honored with the prestigious Louis I. Grossman Award for cumulative publication of significant research studies by the American Association of Endodontists at their Annual Meeting in 2010.

Topic: Treatment of orofacial infections of endodontic origin



Leif K. Bakland, DDS (USA)

Dr. Bakland is a graduate of the School of Dentistry, Loma Linda University. He completed his endodontic residency at Harvard School of Dental Medicine in Boston. His research and teaching interests include endodontics and dental traumatology. In 1994, on a WHO Fellowship, he worked with Dr. Jens Andreasen in Copenhagen on intrusive luxations. Dr. Bakland has been active in the promotion of a better understanding of the treatment of traumatic injuries and has written book chapters and journal articles on the subject. He currently serves as an Associate Editor of Dental Traumatology.

Topic: Biological basis for treatment decisions in dental trauma



Robert S. Roda, DDS, MS (USA)

Dr. Roda graduated from the Faculty of Dentistry at Dalhousie University in Halifax, Canada in 1981 and maintained a full-time private general practice in Dartmouth, Nova Scotia for ten years. He returned to school at Baylor College of Dentistry in Dallas Texas, and received his Masters of Science (Oral Biology) and Certificate in Endodontics in 1993. He became a Diplomate of the American Board of Endodontics in 1998. Dr. Roda has published and lectured internationally, most recently co-authoring the chapter on non-surgical retreatment in the 10th edition of "Pathways of the Pulp". He is an Adjunct Assistant Professor at Baylor, Immediate Past-President of the American Association of Endodontists, and is an

active member of the American Dental Association. Dr. Roda is an Associate Editor of the Journal of Endodontics, and is the Endodontic Consultant to the Arizona State Board of Dental Examiners. He maintains a private practice limited to Endodontics in Scottsdale, Arizona.

Ziv Simon, DMD, MSc (USA)

Dr. Simon is a Diplomate of the American Board of Periodontology and a Fellow of the Royal College of Dentists of Canada. He publishes and lectures nationally and internationally on esthetic tissue reconstruction and computer-guided implant dentistry. Dr. Simon is the founder of the Beverly Hills Multidisciplinary Dental Study Group and the president of the Beverly Hills Academy of Dentistry. He maintains a private practice limited to periodontics and dental implants in Beverly Hills, California. Dr. Simon is the creator of SurgicalMasterTM, a surgical training program for dentists.

Topic: Crown lengthening and management of soft tissues for successful results



Bernadette Jaeger, DDS (USA)

Dr. Jaeger is Associate Professor in the Department of Anesthesiology, UCLA School of Medicine and the Section of Oral Medicine and Orofacial Pain, UCLA School of Dentistry. She is Chair of the Oral Exam Committee of the American Board of Orofacial Pain, having been actively involved in both written and oral examination development since the Board's inception in 1994. Dr. Jaeger developed and directed both a post MD/DDS fellowship training program and a patient care program for chronic head and neck pain at the UCLA Pain Management Center. She is currently involved in the development of a new multi-disciplinary Comprehensive Pain Center at the UCLA School of Medicine. Dr. Jaeger has made

substantive original contributions in the field of pain management, publishing numerous frequently cited, peer-reviewed articles and several book chapters, including the "Overview of the Head and Neck Region" in the second edition of Travell and Simons "Myofascial Pain and Dysfunction, The Trigger Point Manual" Vol. 1, and the very popular chapter on Non-odontogenic Toothache and Chronic Head and Neck Pain in Ingle's gold standard "Endodontics" textbook. Dr. Jaeger has lectured nationally and internationally and is well known for her expertise in myofascial pain.

Topic: Non-odontogenic toothache



Anibal R. Diogenes, DDS, MS, PhD (USA)

Dr. Diogenes received his D.D.S. from the Federal University of Pernambuco in Brazil, his M.S. in Molecular Biology from the University of Nebraska, and his Ph.D. in Pharmacology and Certificate in Endodontics from the University of Texas Health Science Center at San Antonio. Dr. Diogenes is an assistant professor and Director of the Advanced Education Program in Endodontics at the University of Texas Health Science Center at San Antonio. He maintains a private practice limited to endodontics. His areas of research include pain, neuroscience and regenerative endodontics. In addition, he is an Associate Editor for the Journal of Endodontics, President of the International Association for Dental Research Pulp Biology

and Regeneration Group, and a Diplomate of the American Board of Endodontics.
